SARATOGA SD Tournament Behavior/Conduct Contract

1. There will be no fighting or foul language.
2. Non-prescription drugs and alcoholic beverages are forbidden and possession/use will result in legal penalties.
3. No smoking or chewing of tobacco or other illegal substances will be allowed.
4. Formal dress is mandatory (boys wear ties; girls wear dresses or skirt/blouse/jacket; no jeans, no hats, girls please no tank sleeves, no sunglasses during a round, etc.).
5. Competitors may not have friends and/or non-speech and debate students attend any tournament.
6. Students must never leave tournament grounds without permission from a coach or other such adult authorities.
7. Students must be on time for registration and for each of their rounds.
8. If a student signs up for an event, s/he must attend each round of that event regardless of the circumstances.
9. During a round, students must not display any rude or inconsiderate behavior. Good judgment and thoughtful courtesy must be exercised at all times. The best speakers and debaters are also good listeners.
10. Students will not display excessive and unnecessary friendship toward the judge in his/her round, and will respond to the judge only when necessary.
11. Students will not openly express their comments, orally or electronically, about a school or person if the comment is of a hostile or negative nature.
12. Vandalism or defacing of property will be prosecuted to the fullest extent of the law.
13. Students will not enter any room or area where they have not been given permission to enter. Likewise, students will refrain from touching or using any facilities that they have not been given permission to touch or use (pianos, display cases, etc.)
14. Students will use their best judgment in not taking any actions that in any way stains the name of Saratoga Speech and Debate.
15. Students will comply with all rules and regulations set forth in the Saratoga High School Academic Code of Conduct.
16. Failure to comply with these rules and guidelines will result in dismissal from all future activities for the year involved with Saratoga Speech and Debate without a refund of dues.
